

# **Sunsmart Policy**

## **Background**

Too much of the sun's UV radiation can cause sunburn, skin and eye damage and skin cancer. Infants and toddlers up to four years of age are particularly vulnerable to UV damage due to lower levels of melanin and a thinner stratum corneum (the outermost layer of skin). UV damage accumulated during childhood and adolescence is associated with an increased risk of skin cancer later in life.

Werribee Primary School has developed a SunSmart Policy to ensure that all students and staff attending this school are protected from skin damage caused by the harmful ultraviolet rays of the sun. It is to be implemented with the sun protection measures listed below used for all outdoor activities from the **mid-August to the end of April.** Average daily UV levels reach three and above (the level that can damage skin and eyes) during this period.

## **Purpose**

To provide all students, parents and staff attending Werribee Primary School with SunSmart strategies, that will protect them from sun damage caused by the harmful ultra-violet rays of the sun and provide safe UV exposure for vitamin D.

#### **Implementation**

As part of general SunSmart strategies, our school will address the following behaviours, curriculum and environment matters listed below. This policy applies to all school events on and off site.

# **Behaviour**

- All staff and students are required to wear hats that protect their face, neck and ears (legionnaire, broad-brimmed or bucket hat), whenever they are outside. Peak caps and visors are not considered a suitable alternative. Children are required to wear an approved Werribee Primary School hat as sold at Rushfords Schoolwear.
- Sun protective clothing is included in our school uniform / dress code and sports uniform. School clothing is made of close weave fabric and includes shirts with collars and longer sleeves, longer style dresses and shorts and rash vests or t-shirts for outdoor swimming.
- Werribee Primary School will provide SPF30 (or higher) broad-spectrum (Coles every day sunscreen), water-resistant sunscreen for staff and student use.
- Sunscreen is applied at least 20 minutes (where possible) before going outdoors and reapplied every two hours or more frequently if sweating or swimming.
- Strategies are in place to remind students to apply sunscreen before going outdoors (e.g. reminder notices, sunscreen monitors, sunscreen buddies).
- Ensure students are encouraged and supported to develop independent sun protection skills to help them be responsible for their own sun protection.
- Students who do not have appropriate hats or outdoor clothing are asked to play in the shade or a suitable area protected from the sun.
- Encourage children to use available areas of shade for outdoor activities.
- Teachers/staff will be required and parents encouraged to model SunSmart behaviours.
- Students will be encouraged to regularly drink water during warmer weather.

#### Curriculum

- Programs promoting SunSmart behaviour, vitamin D and skin cancer prevention will be incorporated into the curriculum at all year levels.
- The school will regularly reinforce SunSmart behaviour in a positive way through the school website, school assemblies, enrolments and student and teacher activities.

• Ensure the SunSmart policy is reflected in the planning of all outdoor events (eg. Camps, excursions, sporting events).

## **Environment**

- The School will where possible schedule outdoor activities to minimise time in direct sun.
- Outdoor activities will be arranged to be held in areas with plenty of shade whenever possible.
- The Facilities Committee will work towards maintaining and increasing the number of adequate shaded areas so as to provide adequate shade in the school grounds.

### **Evaluation**

The school council and staff regularly monitor and review the effectiveness of the SunSmart policy (at least once every three years) and revise the policy when required by completing a policy review and membership renewal with SunSmart at http://www.sunsmart.com.au/
